

TEXAS TALENT COMPETITION

AUDITION RULES AND REGISTRATION FORM

PURPOSE

The purpose of the Texas Talent Competition is to showcase talented Texas youth that would like the opportunity to expand their musical performance portfolio.

PRIZE

Competitors will perform one (1) song of their choice in front of a panel of judges from the country music industry. The winner will receive an invitation to be the featured entertainment at the Miss Rodeo Texas Pageant coronation on Friday, June 24, 2011 at the Holiday Inn San Antonio International Airport Hotel. The winner's photo and biography will also be included in the Miss Rodeo Texas Program book which is distributed statewide.

REQUIREMENTS

You must be able to prove at the time of your registration and audition that:

- you are a resident of Texas;
- you are 24 years-old or younger on May 1, 2011 (which means you must be born on or after May 1, 1987);
- contestants must compete individually, no groups allowed; and
- contestants must submit an application and \$25 fee by April 25, 2011

You may not have any of the following agreements in effect (written or oral):

- a contract for talent representation (for example, a talent agent or manager);
- a music recording contract;
- an agreement relating to the use of your name, voice and/or likeness; or
- an exclusive acting contract.

DATE AND LOCATION OF AUDITIONS

The Texas Talent Competition will be held on Sunday, May 1, 2011 at the Holiday Inn San Antonio International Airport Hotel at 77 Northeast Loop 410. Registration will begin at 12:30pm and auditions will be held from 1-4pm.

THE AUDITION PROCESS

Contestants will perform in the order in which they register. Auditions will begin promptly at 1pm and be closed to the public. Family and friends may listen from outside the door but may not enter the audition room.

What to Bring on Audition Day:

- You **MUST** bring at least one (1) form of ID to registration day that shows proof of your age and residency (for example, a driver's license or a school ID card). You may also bring a copy of your birth certificate as proof of age but you must bring another piece of documentation verifying your Texas residency. Contestants under 18 years of age on May 1, 2011 must be accompanied by an adult.
- Two (2) copies of your music with no vocals. One (1) copy on a cd and one (1) copy of the MP3 file on a USB drive.
